Objectives and Investment Policy

- The fund aims to achieve long-term capital growth and income.
- The fund will seek to achieve its objective by obtaining exposure to a diversified portfolio of investment grade government and corporate bonds issued by issuers located anywhere in the world.
- The fund may invest up to 20% of its net assets in sub-investment grade or unrated government and corporate bonds.
- The fund will not actively focus on any specific geographic region, industry sector or issuer capitalisation.
- The fund may invest in assets directly or achieve exposure indirectly through other eligible means including derivatives. The fund can use derivatives with the aim of risk or cost reduction or to generate additional capital or income, including for investment purposes, in line with the fund's risk profile.
- The fund may also invest on an ancillary basis, in cash and cash equivalents for cash management purposes and in shares or related securities of companies.
- The Investment Manager has a wide range of discretion over the composition of the fund's portfolio. It may take exposures that are not included in, and that have different weightings from, the Benchmark. Therefore, there are no restrictions on the extent to which the fund's performance may deviate from that of the Benchmark.
- The fund is actively managed and references the Bloomberg Barclays Global Aggregate Index (hedged to GBP) (the "Benchmark").
- The Investment Manager may set internal guidelines which, in turn, may reference deviations from the Benchmark.
- The Investment Manager has appointed a number of discretionary investment advisers as its delegates and will allocate some or all of the fund's assets to such advisers.
- Units can usually be bought and sold each business day of the fund.
- Income is accumulated in the unit price.

Risk and Reward Profile

- The fund may invest in instruments denominated in currencies other than the fund base currency. Changes in currency exchange rates can therefore affect the value of your investment.
- Currency hedging may be used which aims to reduce the effect of such changes. However, the effects may not be completely eliminated to the degree expected.
- The use of derivatives may result in "leverage" by which we mean a level of exposure which could expose the fund to the potential of greater gains or losses than would otherwise be the case.
- There is a risk that the issuers of bonds may not be able to repay the money they have borrowed or make interest payments. While we seek to mitigate this, the fund may be exposed to the risk of financial loss if it invests into an instrument issued by an entity that subsequently defaults on its borrowings. Losses may also be realised if an entity that the fund is exposed to ceases to make interest payments over a period of time or indefinitely. Bond prices have an inverse relationship with interest rates such that when interest rates rise, bonds may fall in value. Rising interest rates may cause the value of your investment to fall.
- The fund may be exposed to the risk of financial loss if a counterparty used for derivative instruments subsequently defaults.

Charges for this fund (ISIN: IE00BZ18RM86)

The charges you pay are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

One-off charges taken before or after you invest

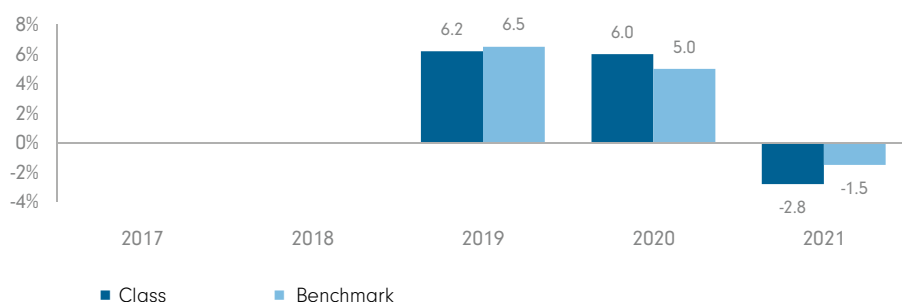
