### Objectives and Investment Policy

- With effect from 01/12/2021, the performance Benchmark for the unit class was changed.
- The fund aims to achieve long-term capital growth.
- The fund will seek to achieve its objective by obtaining exposure to a diversified portfolio at least two thirds of which will be exposed to shares or related securities of companies that have their head office or a main part of their activity in the United Kingdom.
- The fund will not actively focus on any specific geographic region within the United Kingdom, industry sector or market capitalisation.
- The fund may also invest on an ancillary basis, in investment grade government and corporate bonds and convertible bonds, and for cash management purposes in cash and cash equivalents.
- The fund may invest in assets directly or achieve exposure indirectly through other eligible means including derivatives. The fund can use derivatives with the aim of risk or cost reduction or to generate additional capital or income, including for investment purposes, in line with the fund's risk profile.
- The fund is actively managed and references the FTSE All Share Total Return Index (the "Benchmark").
- The Investment Manager has a wide range of discretion over the composition of the fund's portfolio. It may take exposures that are not included in, and that have different weightings from, the Benchmark. Therefore, there are no restrictions on the extent to which the fund's performance may deviate from that of the Benchmark.
- The Investment Manager may set internal guidelines which, in turn, may reference deviations from the Benchmark.
- The Investment Manager has appointed a number of discretionary investment advisers as its delegates and will allocate some or all of the fund's assets to such advisers.
- Units can usually be bought and sold each business day of the fund.
- Income is accumulated in the unit price.

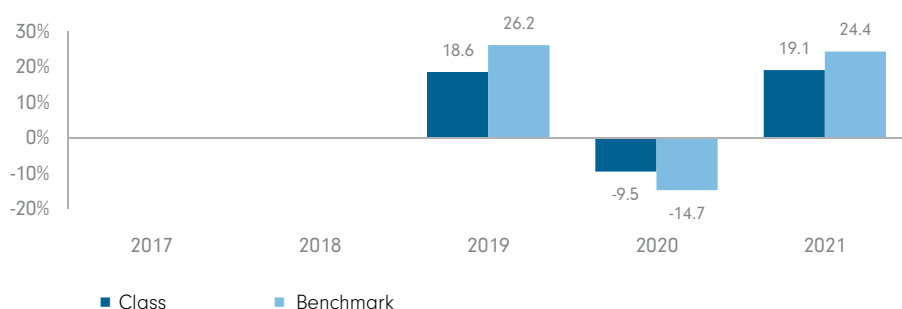
