EU Regulation (2019/2088) on sustainability- related disclosures in the financial services sector (SFDR) - Preliminary notification of self-certified Article 8 Funds

Under SFDR Fidelity International (FIL) is required to categorise its products under Article 6, Article 8 and Article 9. The list below identifies the FIL funds registered or passported in Ireland which FIL has identified and will self-certify to the relevant regulator as being Article 8 funds. This is subject to regulatory endorsement and visa stamping of the relevant prospectus which will contain the pre-contractual disclosures mandated by Article 8 SFDR.

These funds are part of the Fidelity Sustainable Family, a dedicated fund range exhibiting enhanced sustainable characteristics - a minimum of 70% of a fund's net assets are invested in securities deemed to maintain sustainable characteristics and additional ESG criteria apply, as further described in the prospectus.
